21st Forum Forestier Lémanique Wednesday 6 June 2018 at the Hepia University in Geneva and in the Pays de Gex

How are local communities involved in sustainable forest management?

Across the world, local communities and indigenous peoples share a close link to the forests that surround them. This link can be stronger or weaker, according to these peoples' dependence on forest resources, their history, knowledge, and experiences, and their attachment to the forest, but also according to the recognition and authority that they possess as decision makers, owners and/or managers of these forests.

The importance of the involvement of local communities in land management, including forest, has been acknowledged at the international level. In addition, governance by indigenous and local communities has been indicated by the International Union for the Conservation of Nature and the Convention on Biodiversity as comprising a separate category in the structure of governance of protected sites.

With the example of a people of the Amazon, one of whose representatives will be with us, we will see how property rights and community usage are acknowledged in other areas, and what are the constraints and the benefits to community involvement in forest management in Africa and Latin America. Then we will discuss the same questions as they affect towns and forest communities in the Lake Leman area.

We are interested in the regulations and the scope for manoeuvre for these communities compared to public and private owners. We seek to understand their interests and difficulties, how they are organized and what are the results for management of their forests.

The Forum Forestier Lémanique for its 21st meeting day will cover the involvement of local communities in sustainable forest management. It will have the opportunity to welcome international speakers who will discuss their projects in African and Latin American communities. For the Lake Leman region we will also have the opportunity to welcome representatives of municipalities and communities, forest associations and collectives, to share their experience in managing Swiss and French forests. After a morning of conferences and discussions, the participants will have lunch in Divonne and then have the chance to visit the forests of Mont Mourex and Mont Mussy in the Pays de Gex. Mont Mourex has an unusual forest management with a strong involvement by local people.

Whether you are part of the forest community – or environmental protection – involved with local communities or indigenous peoples, member of a communal council or just interested in these questios at the local, national or international level, you are welcome to join us for a day of sharing and exchanges.
